Respected Sir/Madam,

I am writing to bring to your immediate attention a grievance regarding the non-registration of my complaint against MCK Chits Ltd. regarding a financial fraud/cheating case.

I am a victim of financial fraud committed by the aforementioned company. I have been attempting to file a criminal complaint to recover my hard-earned money, but I am being made to run from one police station to another without any legal remedy.

Please note that have paid all my monthly chit amount to this MCK chits Pvt. Ltd. from ICICI Bank, which operates on Shornur Road, Thrissur Town.

The sequence of events is as follows:

1. Rejection by East Police Station: I first submitted my petition to the East Police Station on 12/09/2025 (Ref No: 15996001-2025-5-01019). The Station House Officer there informed me that the accused company's office premises do not fall under their jurisdiction and directed me to submit the complaint to Nedupuzha.

2. Rejection and Closure by Nedupuzha Police Station: Following this instruction, I submitted the petition to Nedupuzha Polices station. However, I have now learned that they have closed the petition stating that the matter does not fall within their jurisdiction either.

3. Lack of Intimation: Most distressingly, the East Police station closed my complaint without any prior notice, written intimation, or reason provided to me.

My Submission: As a common citizen, I am unable to determine the exact technical boundaries of police station limits. The Hon'ble Supreme Court of India has clearly stated that a police station cannot refuse to file a complaint over jurisdictional issues and must register a "Zero FIR" if necessary, transferring it to the appropriate station later.

Currently, both stations are denying responsibility, leaving me without a remedy while the accused parties go free.

Prayer: I humbly request your good office to:

1. Call for the files regarding the reference numbers mentioned above.
2. Determine which Police Station has the correct jurisdiction to investigate this matter.
3. Issue a direct order to the concerned Station House Officer to register an FIR immediately and commence the investigation.
4. Enclosed My Petition copy which I submitted in both police station
